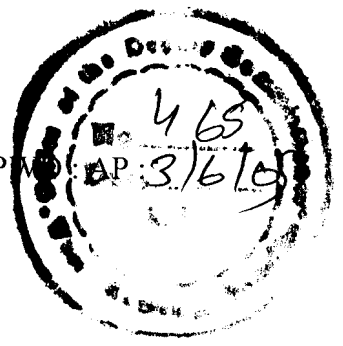

NOTICE INVITING BID

The Executive Engineer, PWD, Bomdila, on behalf of the Governor of Arunachal Pradesh, invites sealed Bid from interested bidders for disposal of different survey reported items under Bomdila PW Divisions, as listed below, upto 3.00 Pm on **15.06.2009**.

Bids will be opened on the same day at 4.00 p.m. by the Executive Engineer or his authorized representative in presence of intending bidders. Bid security should be deposited in the form of deposit at call receipt / Demand draft of a Scheduled Bank guaranteed by the State Bank of India along with the Bid. No Bank guarantee shall be accepted.

Bid documents shall be available for sale in the office of the Executive Engineer, PWD Division, Bomdila at 10.00 am and 4.00 pm from **28.05.2009 to 11.06.2009** every day except on Sundays and Public Holidays.

The following important points should be carefully noted by intending bidders.

- i) The bidders who do not deposit Bid security in the prescribed manner shall be rejected.
- ii) The bidders shall quote the net amount being offered for the stores at the individual location. No item-wise rate shall be quoted.
- iii) The intending bidders shall be quoting for all the store items as listed out in the schedule of quantity. No bidding for partial quantities of the stores shall be allowed.
- iv) The highest successful bidder shall deposit the bid amount within 7(seven) days of the issue of notice of acceptance of the bid, failing which the next higher bidder shall be given an opportunity on the same line. The bid security amount shall stand forfeited for such defaulters.
- v) Any bid below the reserve price shall be rejected.
- vi) The stores shall be open for inspection from 9.00 am to 12.00 noon for five days from **29.05.2009 to 02.06.2009** to those intending bidders, who have purchased the bid documents and produce it before the representative of the Department at stores site. No other person shall be allowed to inspect the stores.
