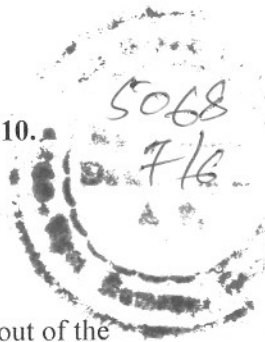

NOTICE INVITING QUOTATION

Sealed Quotations are hereby invited from the interested persons/party for leasing out of the Parking Place at Bomdila located near Hotel Sipyangphong on monthly rental basis for parking of four wheeler light vehicles and two wheeler vehicles.

The sealed Quotations shall be received in the office of the Deputy Director, UD & Housing – Cum – Member Secretary, District Urban Development agency (DUDA), Bomdila upto 1600 hours in all working days till **15<sup>th</sup> June'2010.**

Sealed quotation shall be opened on **16<sup>th</sup> June'2010 at 1500 hrs** in the office chamber of Deputy Director in presence of all the bidders. The result of successful bidder shall be notified in the Notice Board by **18<sup>th</sup> June'2010** after acceptance by the board members & formal approval of the Deputy Commissioner – Cum – Chairman, DUDA, Bomdila, West Kameng District.

TERMS & CONDITIONS :-

1. A prescribed application form shall be issued on all working days from the UD & Housing, Division office, Bomdila on payment of **Rs. 100/- (Rupees hundred)** only in cash which is non -- refundable.
2. The form should be duly filled up and submitted in sealed envelope alongwith supporting documents as asked.
3. The local entrepreneur having Schedule Tribe & Permanent Residential Certificates of Bomdila, West Kameng District (AP) is eligible for submission of sealed quotation.
4. The reserve price shall not be less than **Rs. 51,000/- (Rupees Fifty one thousand)** only per month.
5. The rate quoted by the applicant for monthly rent of Parking Place should not be below the reserved price.
6. Solvency certificates not less than Rs. 5.00 lakhs (Rupees five lakhs) only transaction from any recognized financial institution / commercial bank should be produced.
7. The bidder should furnish an NOC (No Object Certificate) from cooperative Apex Bank.
8. The Deputy Commissioner – Cum – Chairman, DUDA, Bomdila, West Kameng District reserves the right to reject or cancel all or any doubtful sealed quotation without assigning any reason thereof. Any dispute which arises shall be settled by the board of officers under the Chairmanship of Deputy Commissioner-cum-Chairman, DUDA, Bomdila on the merit of the case.
9. The highest bidder shall be given first priority, provided it meets all the requirements and other terms and conditions.
10. A "Lease Deed" will be signed between the successful bidder and Deputy Director –cum- Member Secretary, DUDA, Bomdila before the First Class Magistrate and such Lease Deed will valid for 1 (One) Year only. After completion of the valid term the bidder may renew for subsequent year or re -notice of quotation may be invited

11. The Successful bidder, after acceptance by the board members and approved by the Deputy Commissioner –Cum - Chairman DUDA, Bomdila should deposit the security amount equal to 1 (one) month rent in an advance by Bank Draft / Cheque / Cash in favour of Deputy Commissioner –cum-Chairman, DUDA, Bomdila.
12. The Successful bidder on or after acceptance by the board shall be given 7 (Seven) days period from the date of acceptance to deposit the security amount as per his/her bids. In case he/she fails to do so, his/her application will be cancelled and in such case the next highest bidder shall be given the same chance in same manner.
13. The security amount for a sum of Rs. 51,000/- equal to 1(one) month rent will be forfeited, if the bidder quit before the expiry of term.
14. The successful bidder should take care of whole building and repair & maintenance should be done once in a year at his /her own cost and expenditure.
15. The successful bidder should also take care of vehicles those parks in.
16. The successful bidder should keep watch and ward duty round the clock.
