1. ON 05 FEBRUARY 2004 INTELLIGENCE ABOUT TERRORIST PRESENCE IN VILLAGE SANAI WAS RECEIVED FROM POLICE STATION SURANKOTE. 15 ASSAM REGT LAID CORDON BY 0300 HOURS ON 06 FEBRUARY 2004.

2. AT APPROXIMATELY 0400 HOURS NUMBER 4365338W SEPOY NGAWANG TENZING OBSERVED ONE TERRORIST TRYING TO ESCAPE INTO SANAI JUNGLE ADJACENT TO SANAI NALA. HE AND HIS BUDDY IMMEDIATELY MOVED TO INTERCEPT THE TERRORIST, WHO NOTICED THIS MOVE AND FIRED AT THEM IN A BID TO FLEE INTO THE FOREST. ON COMING UNDER EFFECTIVE FIRE, SEPOY NGAWANG TENZING TOOK COVER AND RETURNED FIRE IMMEDIATELY. HOWEVER, THE TERRORIST RUSHED TO THE FRINGES OF FOREST INDISCRIMINATELY FIRING HIS AK-47 RIFLE BACKWARDS IN WHICH SEPOY NGAWANG TENZING WAS INJURED ON HEAD AND FACE. ALTHOUGH CRITICALLY INJURED, SEPOY NGAWANG TENZING WITH UTTER DISREGARD TO HIS PERSONAL SAFETY CLOSED ON TO THE TERRORIST AND KILLED HIM.

3. IN THIS ACTION HE WAS GRIEVOUSLY INJURED AND HE SUCCUMBED TO HIS INJURIES. NUMBER 4365338W SEP NGAWANG TENZING SET A PERSONAL EXAMPLE OF COURAGE, SELFLESS SERVICE, REGARDLESS OF PERSONAL SAFETY THUS MAKING THE SUPREME SACRIFICE OF HIS LIFE IN THE HIGHEST TRADITION OF THE ARMY.

2. AT 0400 HOURS NUMBER 4368784H SEPOY SONAM RINCHIN OBSERVED ONE TERRORIST TRYING TO ESCAPE INTO THE SANAI NALA. SEPOY SONAM RINCHIN AND HIS BUDDY PAIR IMMEDIATELY MOVED TO INTERCEPT THE TERRORIST. THE TERRORIST NOTICED THIS MOVE AND FIRED AT THEM IN A BID TO FLEE INTO THE FOREST. ON COMING UNDER EFFECTIVE FIRE, HIS BUDDY PAIR TOOK COVER AND RETURNED FIRE IMMEDIATELY AND IN THE MEANWHILE SEPOY SONAM RINCHIN CRAWLED CLOSE TO THE TERRORIST THUS TOOK HIM BY SURPRISE AND PREVENTED HIS ESCAPE. HOWEVER, THE TERRORIST RUSHED TO THE FRINGES OF FOREST INDISCRIMINATELY FIRING HIS AK RIFLE BACKWARDS IN WHICH SEPOY SONAM RINCHIN WAS GRIEVOUSLY INJURED.
