

DA PROHIBITION ORDER

The District Magistrate cum Deputy Commissioner, West Kameng District Dr. Sonal Swaroop, IAS has issued an order under section 133, Cr.P.C prohibiting all kinds of mining activities within the jurisdiction of Bhalukpong sub-division.

The Order dated 10th February, 2017 has been issued to check the reported indiscriminate collection of boulders, Sands 7 minerals from the forests, road sides and river beds in the sub-division.

The prohibitory order further gives any aggrieved parties a period of 15 (fifteen) days to explain why the order should not be made absolute.

**PROHIBITORY ORDER
(U/S 133 Cr.P.C)**

WHEREAS, instances have come to the notice of the undersigned that illegal quarrying of sand, stones, boulders, minerals are being carried out by people at various locations within Bhalukpong Sub-Division.

AND WHEREAS, no mining operations of mines and minerals can be carried out except in places notified as quarry areas under the provisions of the APMMCR 2002.


AND WHEREAS, such indiscriminate collection of stones, boulders, sands, minerals from the forests, road sides and river beds not only violate the relevant provisions of the APMMCR 2002, but also adversely affects the ecology of the area, damages roads and habitations due to changing of river course, floods etc.

THEREFORE, I, Dr. Sonal Swaroop, IAS, Deputy Commissioner-Cum- District Magistrate in exercise of power conferred under section 133 Cr.P.C do hereby prohibit all kinds of mining activities within the jurisdiction of Bhalukpong Sub- Division with immediate effect and until further orders.

The Extra Assistant Commissioner, Bhalukpong shall ensure enforcement of this prohibitory order banning all kinds of mining in his sub-division with immediate effect until further orders and submit weekly report.

The aggrieved parties may present their case before the undersigned within next 15 days explaining why this order should be made absolute.


